## DECREE

**THIS MATTER** came to be heard on July 10, 2003 upon the Petition for Visitation of the  
Petitioner.

**UPON CONSIDERATION** of the evidence, pleadings and documents filed herein as well as the argument and representations of counsel, and in accordance with the standards and requirements set forth in sections 20-124.1 through 124.6 of the Virginia Code, and finding it in the best interests of the minor child of the parties herein,

**IT IS ADJUDGED, ORDERED and DECREED** that Petitioner shall have visitation,  
under the following terms and conditions:

A. Until the Petitioner obtains full time employment, the Petitioner shall have visitation with the Child at all times when the Respondent is at work;

B. Until the Petitioner obtains full time employment, on Monday , the Respondent shall drop off the child at the marital residence between 8::00 A.M. and 8:30 A.M and thereafter the

Petitioner visitation with the Child until the Respondent returns home from work;

C. Until the Petitioner obtains full time employment the Respondent shall drop the Child off at the marital residence <sup>on Tuesday and Thursday</sup> between 8:00 A.M. and 8:30 A. M. and thereafter, the Petitioner shall have visitation with the Child overnight.

D. When the Petitioner obtains full time employment, the Respondent shall drop off the Child at the marital residence between 8:00 A.M. and 8:30 AM. On Tuesdays and Thursdays, and thereafter the Petitioner shall have overnight visitation with the Child ,

E. Starting on August 8, 2003, Petitioner shall have further visitation with the Child on alternate weekends from Friday afternoon when the Petitioner picks up the Child from the school bus through Sunday evening at 5:00 p.m.;

F. The Holiday visitation schedule shall be as follows:

**Valentine's Day:** In even years, the Child shall spend Valentine's day with the Petitioner. If during an even year, February 15<sup>th</sup> , falls on a school day, this visitation shall begin at the end of the school day and end at 7:00 P.M. on Valentine's Day. Or, if it falls on a Friday. the visitation shall begin after school and end at 10:00 A.M. the next day. If during an even year, Valentine's day falls on a weekend when it is the Petitioner's year, then the visitation begin at 9:00 A.M. through 10:00 A.M. the next day. In odd years, the Child shall spend Valentine's Day with the Respondent

**Easter/Spring Break:** In odd years, Petitioner shall have visitation with the Child during the Spring Break. In even years, it shall be reversed and the Child shall spend the Spring Break with Respondent.

**Mother's Day:** The Child shall spend Mother's Day with the Respondent

**Memorial Day Weekend:** In odd years, Petitioner shall have visitation with the Child. In even years, the Child shall spend it with the Respondent.

**Father's Day:** The Child shall spend Father's Day with the Petitioner.

**4<sup>th</sup> of July:** In even years, the Child shall spend the 4<sup>th</sup> of July with the Petitioner. In odd years, the Child shall spend the 4<sup>th</sup> of July with the Respondent.

**Labor Day Weekend:** In odd years, the Child shall spend Labor Day Weekend with Respondent. In even years, it shall be the reverse and the Child shall spend Labor Day Weekend with the Petitioner.

**Columbus Day Weekend:** In odd years, the Child shall spend Columbus Day Weekend with Petitioner. In even years, the Child shall spend Columbus Day Weekend with Respondent.

**Halloween:** In odd years, the Child shall spend Halloween with the Respondent. In even years, the Child shall spend Halloween with the Petitioner.

**Veterans Day:** In odd years, the Child shall spend Veteran's Day with the Petitioner. In even years, the Child shall spend Veteran's Day with the Respondent.

**Thanksgiving Weekend:** In odd years, the Child shall spend Thanksgiving weekend beginning at the end of the school on the last day of school prior to the Thanksgiving Break through 6:00 P.M. on the Sunday after Thanksgiving.

**Christmas Break:**

The Christmas break shall be defined as starting at the end of the school day on the last day of school prior to the school break and ending on the morning of January

2<sup>nd</sup>. In odd years, the Child shall spend the Christmas break, with the Respondent.

In even years, the visitation shall be reversed: the Child shall the Christmas Break with the Petitioner.

**Vacation Time:** In addition to the above visitation schedule, the Child shall spend two seven (7) day consecutive periods with each parent as vacation time.

G. **Precedence:** The Holiday and Vacation Schedules shall supersede the regular visitation schedule.

H. **Notice:**

1. Each party shall give the other party fifteen days notice of any plans to take the Child outside the Washington, D.C. metro area. This notice shall include the proposed dates of the trip, an itinerary, addresses where the Child shall be and telephone numbers where the Child may be reached.

2. Each Parent agrees to notify the other parent as soon as possible and no later than within 24 hours of any medical injury or emergency.


3. Each party agrees to give the other party thirty days notice whenever one intends to use his or her allotted 7-day vacation time.

I. The Petitioner is to comply with the physical therapist's recommendations concerning requirements for Liam's occupational therapy. Documentation concerning the Occupational Therapist's recommendations are to be provided to the Petitioner

AND the Clerk is directed to forward a copy of this Decree to counsel for both parties upon

entry thereof.


