ORDER

THIS MATTER came for hearing on July 10, 2003, upon the Cross Petitions for Custody filed by the Petitioner/ Cross-Respondent, Cheri Smith (“Petitioner”), and Respondent/ Cross-Petition Wesley C. Smith for custody of the minor child, Liam Smith (“the Child”);

UPON CONSIDERATION of the evidence and testimony presented by the parties and witnesses as well as the argument and representations of counsel, and in accordance with the standards and requirements set forth in sections 20-124.1 through 20-124.6 of the Code of Virginia, 1950, as amended, and finding it to be in the best interests of the minor child of the parties herein, it is hereby

ADJUDGED, ORDERED and DECREED that the Petitioner, Cheri Smith, shall have **SOLE LEGAL** and **PRIMARY PHYSICAL CUSTODY** of the minor Child;


AND it is further **ORDERED** that pursuant to Section 20-124.5 of the Code of Virginia, 1950, as amended, that thirty days notice be given to the Court and the other party by any party intending to relocate and of any intended change of address.

The notice shall contain the child's full name, the case number of this case, the party's new telephone number and new street address and, if different, the party's new mailing address. The Notice shall be mailed by first-class or delivered to this Court and to the other party.

AND it is further **ORDERED** that neither party shall be denied access to the academic, medical, hospital or health records of the child unless, otherwise ordered above.

AND the Clerk is directed to forward a copy of this Decree to counsel for both parties upon entry thereof.
