Dear Ms. Smith and Mr. Smith:

This is in response to Ms. Smith's letter dated May 24, 2006, (enclosed) regarding an anticipated change in Mr. Smith's visitation rights. We thank you for keeping us informed of such changes, and we would appreciate if you would provide the school a copy of the court order when it is issued.

The June 17, 2005, Trespass Notice prohibiting Mr. Smith from entering school grounds was not based on Mr. Smith's custodial or visitation rights, but rather, upon Fairfax County Public Schools's (FCPS) legitimate and substantial concerns regarding the threat posed by Mr. Smith to school operations and the safety of FCPS students and staff. Because FCPS continues to have those concerns, and because no new information has been brought to its attention to alleviate those concerns, the restrictions on Mr. Smith's access to Spring Hill Elementary School will remain in place.

Accordingly, as stated in the June 17, 2005, Trespass Notice, Mr. Smith may not enter or remain upon the grounds of Spring Hill Elementary School for any reason, including entering school property to pick up Liam, unless he has received the prior approval of the school administration. Any such request must be made in writing, and FCPS will make every effort to promptly address all such written requests. Mr. Smith will only be permitted on school grounds if he has been provided written permission from a school official in advance of his visit.

FCPS will continue to provide Mr. Smith with the option of participating telephonically in parent-teacher conferences and special education meetings concerning Liam and will continue to mail copies of Liam's quarterly progress reports and other documents pertaining to Liam's program of special education to Mr. Smith's home.

RE: Custody and visitation of Liam Smith


Dear Mr. Vanderhye,

As of 23 May 2006, visitation of Liam Smith by his father Wesley Smith was reinstated by the Circuit Court of Prince William County. I maintain legal and physical custody of Liam.

Mr. Smith's visitations with Liam are scheduled well outside school hours, and I do not anticipate he will have a need to drop Liam off or pick Liam up at school. It is my understanding there is a no-trespass order barring Mr. Smith from entering the school grounds; however, from the standpoint of the current custody order, Mr. Smith is allowed to visit with his son, and to pick him up at school if I have provided written permission.

I will provide a copy of the order to the school once it is entered with the court on 9 June.
