Subject: Petition for Prosecutorial inquiry, Violations of Federal and State laws by a officer of the court and civil rights violations.

Dear Mr. Gonzales:

I respectfully request your office to direct a investigation into the actions of Mr. Robert Machen (VSB:20287) a attorney practicing in the Commonwealth of Virginia who has deliberately undermined Justice by committing fraud upon Federal & State Government and fraud upon the court through perjury, falsification of evidence and document fraud.

Fraud has also been committed by misleading State and Federal Agencies including the FBI, The U.S Army, Defense Intelligence Agency, The Counterintelligence division, defense contractor Northrop Grumman.

Evidence of these false allegations is attached hereto as exhibits.

The said offenses are:

- 1) Misleading and undermining the resources of State and Federal Agencies.
- 2) Deliberate abuse and misuse of the U.S Patriot act and other violations including
- (a) Title 18, United States Code, Section 1001 (Misleading a Federal Agency).
- (b) For a violation of Title 18, United States Code, Section 241 (Conspiracy against rights),
- (c) For a violation of Title 18, United States Code, Section 1343/1346 (Deprivation of Right to Honest Services/Document Fraud) and abuse of US

Patriot Act, 18 U.S.C 1030 (2001).

- 3) Racist, vindictive and malicious actions by Robert Machen.
- 4) Perjury (a felony under 18USC§1621 and under §18.2-434 of Virginia Code).
- 5) Fraud on the Court (a felony under 18USC§1001).
- 6) Conspiracy to defraud the United States (a felony under 18USC§371).
- 7) Deliberately misleading through giving conflicting testimony on separate occasions as to the same matter (a felony §18.2-435 of Virginia Code).
- 8) Combination to injure others in their reputation, business or professional (a misdemeanor under §18.2-499 of Virginia Code).
- 9) Deprivation of civil rights under color of law, including imprisonment (a misdemeanor under 18USC§242).

This complaint also focuses on falsification of documents, (exhibit 2) statements (exhibit 3) and affidavit(exhibit 4) by MACHEN designed specifically to damage and undermine my reputation with the U.S Department of Defense, to cause me to loose employment and to reap personal advantage for his client.

Deliberately misleading State and Federal Agencies pursuant to this complaint began in the Fall of 2002 with the initiation of a fabricated allegation with the FBI on or about September, 2002 and carried through October of 2003 and on going currently with various false allegations including a fabricated letter with my signature forged and sent to the Homeland Security Department (former Immigration and Naturalization Service) (exhibit 5), falsification of affidavit, perjuring and coercively persuading his client to file complaints with the FBI on a scam investigation. This abuse did not stop with the FBI. Mr. Machen went on to engage private defense companies who were contracting with me including Northrop Grumman (exhibit 6) a Defense Contracting Company whose chief of Security Mr. William Tate and Mr. Craig Mogus were sent extremely inflatory subpoena designed to disrupt and undermine my reputation with those companies. On that date and since then in the J&DR Court and later in the Circuit Court in Fairfax hearings Mr. Machen committed perjury or otherwise engaged in misconduct and stated:

- 1. On or about October 2002 MACHEN perjured himself in the Court of Honorable Judge David Snell of the J&DR Court stating that Mr. Jagannathan was under investigation by the FBI and he has been instructed not to reveal that fact to him, answering discovery response would violate that instruction. Should the court direct him to respond to discovery requests he would do so in camera in the Judge's chambers.
- 2. Perjured himself in the court stating that he could not disclose documents that the Federal Bureau of Investigations ordered him not to be disclosed (exhibit 7) which I have later learned from the FBI were false.
- 3. Falsified a affidavit presented to the Department of Justice and the FBI by predating a notarized signature to water down the evidence of a fax that was discovered addressed to MACHEN about conspiracy to file a complaint with the FBI for advantages in a litigation.

- 4. Perjured himself stating that the Federal Bureau of Investigation had instructed him that upon a court order he could release the affidavit(exhibit 8). Mr. Machen was not instructed by the FBI.
- 5. Further proof of fabrication of evidence A Faxcimile letter received by Mr. Machen dated September, 2002 (exhibit 5) states that Mr. Jagannathan's green card may be revoked if there was a investigation of any complaint by the FBI.
- 6. Perjured himself and his client to mislead a Federal Agency through false statements, affidavits, and documents.
- 7. Mr. Machen's client admitted to being coercively persuaded to make these false statements to federal state agencies. Had stated that they were her attorney's strategy. Valeria Jagannathan also stated to a counselor "Phyllis Robinson" of the J& DR court who has documented them in her report that Valeria "the client" was not in fear of these crimes supposedly committed by Rajan Jagannathan.
- 8. Mr. Machen had stated openly of his dislike for interracial marriages and had vowed he would work pro bono to prevent a "mongrel race in Virginia".
- 9. Mr. Machen is using the courts to cover up his crimes, perjury, and fraud and those actions indicate a probable cause to believe, and I do believe that Mr. Machen caused the placement of controlled narcotic substance in my minivan in his devious attempts to get me arrested on a Felony charge. Distribution of a controlled substance. "fourteen 1 gram packet of cocaine was found in the tools compartment of my minivan. I have reason to believe this is an effort to preempt any action or complaints from me against him.
- 10. A private investigation revealed that Mr. Machen has had a history of falsifications, He has had district committee sanctions against him, The Virginia State Bar had suspended his license for falsifying documents previously, He has had other sanctions brought against him by the Bar.
- 11. Three Judges appointed by the Chief Justice of the Supreme Court of Virginia, Honorable Judge Thomas D. Thorne, Judge Dickson L. Foster, Judge Robert K. Woltz had found by clear and convincing evidence that Mr. Machen engaged in conduct for personal advantage, involving deceit that reflects adversely on his fitness to practice law and found him guilty under DR1-102(A)(4) of code of professional responsibility. The Organization Citizen for Legal Reform reports Mr. Machen has engaged in conduct which tends to undermine the administration of justice and to bring legal businesses into disrepute.
- 12. U.S Attorneys have stated that Mr. Machen has had been convicted of a felony before the Honorable Albert V. Bryan, Jr. in the United States District Court for the Eastern District of Virginia for Title 18 USC, 1503; Obstruction of Justice & Engaging in misleading conduct with intent to alter records in Violation of 18 USC, 1512.

Mr. Gonzales, I am a lawfully admitted resident living in the U.S. for the last fifteen years. I have served the Department of Defense to further the security of the United States. My contributions as a systems Engineer to the United States Department of Defence and in particular the PERMS (Personnel Electronic Record Management System) were highly appreciated by the Army, The Navy and the Marines who recommended me for an accelerated United States Citizenship. I currently work at the Pentagon as a consultant.

I would like to see a process in place where I and others like me similarly placed would be able to seek relief and justice against malicious prosecution by unethical individuals. These individuals like Robert Machen are abusing the Patriot act and other executive orders, undermining and compromising the very act itself as well as the Security of our country as well as undermining the livelyhood of individuals.

I have been a victim of malicious prosecution by Mr. Machen I would like to see people like Mr. Machen and particularly him and all others who abuse the Federal and state Laws prosecuted.

I seek the help of the Department of Justice against malicious and vindictive persecution by Mr. Machen. Will you direct your department to help me?

Mr. Gonzales, the bottom line is, my private investigation has discovered evidence that Mr. Machen in serious violation of civil rights, and abuse of federal agencies Special Agent Mr. Mark Stanley of the FBI stated that the Civil rights division was interested in investigating until he learned that the U.S Attorney Office may not prosecute based on that investigation.

Therefore, I respectfully request you on the following preliminary course of action:

- 1. To instruct the FBI and the U.S Attorney office to investigate promptly and properly whether the above mentioned offenses were committed by Robert Machen and his agents and to prosecute the offenses, should the investigation confirm them; Mr. Mark Stanley a special agent with the FBI had stated that his department would conduct a investigation if they receives directions from the U.S attorney office of a prosecution for the offenses.
- 2. To instruct the U.S Attorney Office should inform the FBI that they would prosecute if the results of the investigation showed that Mr. Machen has committed perjury and has persuaded his client to perjure to Federal Agencies.
- 3. To Report to the Fairfax County Court the results of the investigation at the date set by the court.
- 4. Report to the Court to reevaluate the case as it is based on perjury.
- 5. Direct a Federal Court to issue a order purging files the FBI, DOJ, the Homeland

Security and other Federal Agencies have on file which is based on fraud and malicious complaints by Mr. Machen and have these expunged or purged from their record.

I assure you that these charges are extremely serious, Mr. Machen for self-serving reasons, has intentionally mislead and undermined the resources of Federal Agencies in the post 911 times and in doing so has compromised the security and interest of the United States, while costing the tax payers.

I will make myself available to the FBI and to other investigators when needed in order to facilitate a investigation of Mr. Machen.
